Details of W.P cases for the Employment under any Local Authority

* The Government of Tamil Nadu had revised the minimum wages for the employment in Local Authority vide GO(2D)No.36, Labour Welfare and Skill Development (J1) Department, dated.16.06.2023 published in the Tamil Nadu Government Gazette on 05/07/23.

The Tirupur Mavatta Ooraga Valarchi Ullatchithurai Oozhiyar Sangam had filed a Writ Petition in WP.No.25345 of 2023 before the Hon'ble High Court, Madras challenging the G.O.(2D).No.36, Labour Welfare and Skill Development (J1) Department, dated.16.06.2023 and the Hon'ble High Court in WMP.No.24753 and 24755 of 2023 vide order dated.28/08/23 granted interim stay of the operation of the order in GO(2D)No.36, Labour Welfare and Skill Development (J1) Department, dated.16/06/23.

Further, in a subsequent development, another Writ Petition in WP.No.26344 of 2023 had been filed by Uzhaippor Urimai Iyakkam. The Hon'ble High Court of Madras and in its order dated. 11.09.2023 has given the following direction:-

"In view of the above submissions, this Court, directs the respondents to pay the minimum wages to the National Urban Livelihood Mission (in short 'NULM') temporary sanitary workers in terms of GO.(2D).No.62, Labour and Employment (J1) Department, dated.11.10.2017, until further orders".

As on date , the aforesaid Writ Petitions are pending and the interim stay / interim direction granted in the Miscellaneous petition continue to be in force.

In view of the pendency of the aforesaid Writ Petitions in which certain interim directions have been passed, DA calculation relating to both the

notifications viz., Notification No.G.O.(2D).No.62, Labour and Employment (J1) Department, dated.11.10.2017 (previous notification) as well as the latest notification GO(2D).No.36, Labour Welfare and Skill Development (J1) Department, dated.16/06/23 are furnished.
